An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate.</div> <div>2. To vote a straight party ticket, blacken the oval (●) to the left of the name of the party of your choice. To vote for an individual candidate of another party after voting a straight party ticket, blacken the oval (●) to the left of his or her name.</div> <div>3. To vote for a person whose name is NOT on the ballot, YOU MUST BLACKEN THE OVAL (●) to the left of the line provided, and write or print the name in the blank space provided for that purpose.</div> <div>4. An oval (●) blackened to the left of the names of candidates for President and Vice-President indicates a vote for all the candidates of that party for Presidential Electors. To vote for individual candidates for Presidential Electors, enter the names in the blank spaces provided under the title "Presidential Electors" and blacken the oval (●) to the left of the first space.</div> <div>5. If you make a mistake, DO NOT ERASE. ASK FOR A NEW BALLOT.</div> <div>6. USE ONLY THE MARKER PROVIDED.</div> <div>7.
