All in favor. Along with that Application, a motion was made by Commissioner McCray authorizing Chairman Ulsh to endorse the JAG Local Jurisdiction Waiver. All in favor.




Due to schedule conflicts, the Board will have their Safety Committee meeting on March 13th at 10:30 a.m. rather than March 20th.

Motion by Commissioner Lynch to endorse the Tax Levy and Appropriation Resolution #2 of 2018. All in favor.


Motion by Commissioner Lynch to adjourn the meeting at 11:45 a.m. All in favor.
