## TAX LEVY AND APPROPRIATION RESOLUTION **RESOLUTION NUMBER** **12 of 2022**

A RESOLUTION OF THE COUNTY OF FULTON, Commonwealth of Pennsylvania, fixing the tax rate for the year of 2023 and appropriating specific sums estimated to be required for the specific purposes of the County government, hereinafter set forth, during the fiscal year.

BE IT RESOLVED AND ENACTED, and it is hereby resolved and enacted by the Board of County Commissioners of the County of Fulton, Commonwealth of Pennsylvania:-

SECTION 1. That a tax be and the same is hereby levied on all real property within the said County subject to taxation for County purposes for year 2023 as follows: Tax rate for general County purposes, the sum of 12.40 mills on each dollar of assessed valuation.

SECTION 2. That a tax be and the same is hereby levied on all occupations within the said County subject to taxation for County purposes for fiscal year 2023 as follows: Tax rate for general County purposes the sum of 0 mills on each dollar of assessed valuation.

SECTION 3. That expenses of the County for the fiscal year 2023 are itemized in the County budget and on file in the office of the County Commissioners.


SECTION 4. The payment Periods and Discount/Penalty rates to established as follows:


- Discount Period-April 1<sup>st</sup> through May 31<sup>st</sup>  
Discount Rate – 2%
- Face Period-June 1<sup>st</sup> through July 31<sup>st</sup>
- Penalty Period-August 1<sup>st</sup> through December 31<sup>st</sup>  
Penalty-5%


SECTION 5. That any resolution, or part of resolution, conflicting with this
