<p>INSTRUCTIONS TO VOTER:</p> <p>1. TO VOTE YOU MUST BLACKEN THE OVAL (○) COMPLETELY.</p> <p>2. An oval blackened (●) to the left of the word "YES" indicates a vote FOR Retention.</p> <p>3. An oval blackened (●) to the left of the word "NO" indicates a vote AGAINST Retention.</p> <p>4. If you make a mistake, DO NOT ERASE. Ask for a new ballot.</p> <p>5. MARK ONLY WITH A BLACK BALLPOINT PEN.</p> <p>6. DO NOT FOLD THE BALLOT unless voting absentee.</p> <p>7. DO NOT tear off the stub. Place this ballot in the secrecy sleeve with only the numbered stub showing before leaving the booth and then show the stub to an election officer. When instructed by the election officer to do so, remove the stub containing the number and then immediately slide the ballot from the secrecy sleeve into the ballot box.
