

# Sample Ballot

## OFFICIAL BALLOT FULTON COUNTY, PENNSYLVANIA MUNICIPAL GENERAL ELECTION, NOVEMBER 2, 2021 McConnellsburg Borough

**1. TO VOTE YOU MUST COMPLETELY BLACKEN THE BOX TO THE LEFT OF YOUR CHOICE.** A box darkened to the left of any candidate indicates a vote for that candidate.

**2. To cast a write-in vote for a person whose name is not on the ballot,** you must darken the box to the left of the line provided and print the name in the blank space provided for that purpose.

**3.** Use **only** a black or blue ink pen.

**4.** If you make a mistake, ask for a new ballot.

**WARNING:** If you receive an absentee or mail-in ballot and return your voted ballot by the deadline, you may not vote at your polling place on election day. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on election day, unless you surrender your absentee or mail-in ballot and envelope to the judge of elections to be voided to vote by regular ballot.
