The Commissioners met with Richard Goldstein and Ali Granmayeh, UAS Asset Management.



The Commissioners met with Michelle Sowers and Stanley Kerlin regarding Clean and Green Matters.


Motion by Commissioner McCray to adjourn the meeting at 2:30 p.m. All in favor.
