Motion by Chairman Ulsh to exit Executive Session at 9:45 a.m. All in favor. No action was taken as a result of this session.


The Commissioners met with Stanley Kerlin-County Solicitor regarding the Computer Network Policy and an ongoing bail bond issue.


Chairman Ulsh asked if the public had any comments.
