As outlined in a letter from the Pennsylvania Emergency Management Agency dated January 12, 2022, Fulton County has been awarded \$215,219.85 of 2021 9-1-1 Statewide Interconnectivity Funding to be used towards the SCM ESInet Maintenance, SAC CHE Maintenance, SAC Regional CAD, SAC CHE Upgrades, SAC GIS Layer Upgrades and SCM Fiber Upgrade projects. Therefore, a Motion by Commissioner Shives to endorse the Commonwealth of Pennsylvania Emergency Management Agency (PEMA) 9-1-1 Statewide Interconnectivity Funding Grant Agreement between PEMA and Fulton County in the amount of \$215,219.85 for the performance period of January 1, 2022 through December 31, 2022.
