After receiving an email from Seleen Shives, Director of the Fulton County Conservation District the Farmland Preservation Appointments that were listed on the Agenda were tabled as Mrs. Shives correspondence indicated the Conservation District is no longer able to administer the Farmland Preservation Program for the County due to significant increase in staff responsibilities, a reduction of staff, lack of financial support from the County for the purchase of easements and a lack of financial support from the PA Department of Agriculture to administer the program.
