Wright also spoke to the Commissioners about paying the remainder of the annual pension contribution to Charles Schwab.


A Safety Committee meeting was held at 10:30 AM and adjourned at 10:46 AM.

**Motion by Commissioner Bunch to adjourn at 11:25 AM. All in favor.**




