Commissioners met with Penn State Extension, via Zoom, to discuss adjusting the \$65,000 quarterly allocation payments for FY 2023 due to the transitioning of the new 4-H Educator and part time Clerk positions. The current Clerk is full time and employed by the county. Penn State will be the employer of both new positions. Beatty suggested keeping the allocation the same as the previous year for the first quarter of 2023 and then making adjustments in the second quarter if the positions are filled by Penn State. Penn State understood that the max allocation will be \$65,000 for the 2023 fiscal year. In attendance from Penn State were Jeff Hackenberg, Client Relationship Manager; Julie Price, Business Operations Manager and Joshua Rice, 4-H Youth Development Program Assistant Director.
