Chairman Ulsh opened the meeting with a moment of silent prayer and all recited the Pledge of Allegiance to the flag.

Motion by Commissioner Shives to approve the Commissioners' Minutes of the February 14, 2023 meeting. All in favor.

A bid opening was held at 9:00 a.m. for the '08 Dodge Charger with one single bid being received. The bid was advertised in the local newspaper and on the county website.

Motion by Commissioner Shives to award the bid to Garrett Bunch for the 08' Dodge Charger in the amount of \$500. All in favor.
