

Meeting of the Fulton County Commissioners Tuesday, June 6, 2023 8:30 a.m. at the Commissioners' Office

Present: Commissioner Ulsh and Commissioner Shives

Absent: Commissioner Bunch

Chairman Ulsh opened the meeting with silent prayer and all recited the Pledge of Allegiance to the flag.

Motion by Commissioner Shives to approve the Commissioners' Minutes of the May 30, 2023 meeting. All in favor.

Motion by Commissioner Ulsh to approve the Accounts Payables dated June 2, 2023 in the amount of \$163,628.24. All in favor.

Commissioners met with Domestic Relations Director Tina Gress to discuss reclassification of job titles to reflect the same title with different levels in the Domestic Relations Department. Motion by Commissioner Shives authorizing Commissioner Ulsh to execute the Agreement between Mission Critical Partners, Inc. and the County of Fulton for consulting services in the EMA/911 Department. All in favor.

Motion by Commissioner Ulsh to approve a Letter of Resignation from Patti Hunsinger, Clerk for the Public Defender's Office, effective immediately and to also approve advertisement for the position. All in favor.

Commissioners discussed the July 4, 2023 Commissioners' Meeting being on a Tuesday and asked Chief Clerk Stacey Golden to cancel the meeting by advertising in the newspaper and on the county webpage. There will not be a makeup date that week for a meeting, but rather meet again on July 11, 2023.
