All in favor.

Motion by Commissioner Shives to approve the Amendment to Project Supplement No. 2022-01 to Grant Cooperation Agreement between Alleghenies Broadband, Inc. (ABI), and Fuiton County to be extended to December 31, 2023. All in favor.

Commissioners met with Executive Development Director Julie Dovey, Family Support Coordinator Tiea Sharer, Executive Director Assistant Rachel Cain, all with Fulton County Family Partnership; Lori Young, Program Specialist for Franklin/Fulton Intellectual Developmental Disabilities Program; James Eagler, Administrator for Franklin/Fulton Drug & Alcohol; Services for Children Director Christine McQuade for the FY23-24 Fulton County Block Grant Plan Public Hearing. Dovey presented handouts explaining what each program within the Block Grant entailed.
