All in favor.

Motion by Commissioner Bunch to approve and execute the Elect Technology Invoice for Election IT Support, in the amount of \$2,590.00. All in favor.

Motion by Commissioner Bunch to approve and execute the East Providence Township, Bedford County, Bike Trail Grant Letter of Support to "bundle road paving and stormwater improvements on three township roads with a new bicycle trail extension stretching from the Pike2Bike trailhead to the western side of township municipal boundary".
