

FULTON COUNTY BOARD OF COMMISSIONERS' MEETING Tuesday, April 22, 2025 8:30 a.m. at the Commissioners' Office

Commissioner Bunch opened up the meeting with prayer. All recited the Pledge of Allegiance to the flag.

Motion by Commissioner Wible to amend the April 22, 2025 Agenda to include "Certificate of Cost Allocation Plan" and "McConnellsburg Volunteer Fire Company Letter of Support". All in favor.

Commissioner Bunch opened up the floor for Public Comment Period. Greg Connelly, 2nd Assistant Chief with the McConnellsburg Volunteer Fire Company No. presented the Commissioners with a Letter of Support addressed to Congressman John Joyce.
