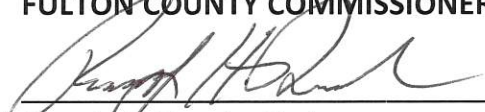
Motion by Commissioner Bunch to enter into Executive Session at 10:52 a.m. for Personnel Matters. All in favor.

Motion by Commissioner Bunch to adjourn at 11:45 a.m. All in favor.

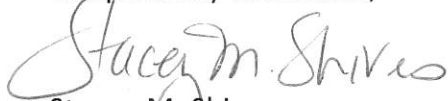
