Commissioner Wible called the meeting to order followed by Commissioner Hann saying a prayer. All recited the Pledge of Allegiance to the flag.

Fulton County residents Carolyn Kerlin and Sandra Barton asked the Commissioners if there were any new updates for the ongoing litigation regarding the voting machines. The Commissioners stated they are still working with legal counsel on the matter.

Commissioners met with Chief Probation Officer Dan Miller for the review and approval of Juvenile Grand in Aid Documents.

Motion by Commissioner Wible to approve and execute the Juvenile Probation Services Program Grant Agreement, Contract Number 4100101052, between the Commonwealth of Pennsylvania acting through the Juvenile Court Judges' Commission and Fulton County. All in favor.

Motion by Commissioner Wible to adjourn at 11:17 a.m. All in favor.




