Motion by Commissioner Wible to transfer Nya Minnier's employment status from Per Diem to Full-Time for the position of "Staff Support", increasing her hours to 30 per week, not to exceed 40 per week unless approved by HR, effective immediately. Commissioner Bunch abstained due to conflict of interest. Motion carried.

Motion by Commissioner Wible to enter into Executive Session for Personnel Matters at 10:33 a.m. All in favor.

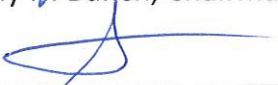
Motion by Commissioner Wible to exit Executive Session at 11:30 a.m. All in favor.

Motion by Commissioner Hann to adjourn at 12:03 p.m. All in favor.

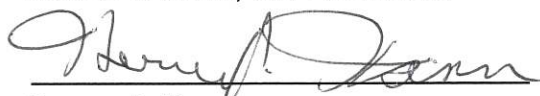

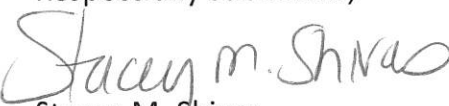
